The Pennsylvania Head Start Association (PHSA) seeks to support 10-50 Early Learning programs in Pennsylvania to increase their capacity to implement farm to ECE strategies that help meet the needs of children and families during and after the COVID 19 pandemic.

Farm to ECE is a group of activities and strategies that offer increased access to healthy, local foods, gardening opportunities and food-based learning activities to improve the quality of Early Learning programs and improve the lives of the program's children, families and staff.

Now, more than ever, farm to ECE strategies can promote long-term equity and resiliency in our communities and shared food systems. Farm to School practices include activities that fall under three main categories: food and agriculture education, hands-on gardening, community links to the local farming sectors and use of local foods for meals, taste tests or events. Farm to school works well in all types of early care and education settings, inclusive of, but not limited to, preschools, Head Start programs centers, family Head Start programs homes, home-visiting, Head Start/ Early Head Start and programs in K-12 school districts. Farm to ECE activities support healthy eating habits, a connection to local food and agricultural communities, and teach children how food grows.

The funding for the capacity building grants is flexible. PHSA expects that grant applications will be based on the principle of locally designed options.

PHSA expects each grantee to complete the Go NAPSAC farm to early learning self assessment to assist in programs reviewing their strengths and where they might improve their farm to early care and education capacity.

PHSA is partnering with The Food Trust to offer technical assistance with select program's grant planning and implementation.

All grants applications must be completed using the Ready, Set, Grow, [Racial Equity Framework](#)¹.

Purpose Statement

Eligible Entities

Pennsylvania Early Learning Programs and Organizations Partnering with Early Learning Programs to Develop Farm to Early Learning Activity Capacity.

Application Selection

Complete applications will be evaluated considering, but not limited to, the following priorities:

- *Racial Equity:* Applicants serving communities lacking access to healthy foods will be prioritized particularly those most impacted by racial inequities. Using our [Racial Equity Framework](#)¹, our Farm to ECE work has shared goals for all children & families, recognizing the need for targeted strategies that take into account specific barriers to food access. While our focus on race is explicit, it is not exclusive. The framework acknowledges the deep interconnections and complex interactions between various forms of oppression. We are working to develop and apply a critical understanding of how children, farmers, families, ECE staff

and others are differently situated according to race, ethnicity, place, socioeconomic status, immigration status, and language, and more.

- *Sustainability:* A project or program that builds the capacity of programs to implement Farm to ECE activities that is sustainable after the grant funds are used.
- *Geographic diversity and variety of ECE settings/program types:* We are seeking to award providers from across the state representing a variety of ECE settings. Geographic diversity and ECE program types may factor into overall award decisions.

Use of Funds

Award money may be spent on costs associated with implementing sustainable systems to support the following activities:

- *The development of partnerships with WIC, Farmers markets or other community stakeholder to increase access to affordable local produce to the site*
- *Locally grown food for taste tests and food preparation with children*
- *Edible plants in gardens, on windowsills, or with indoor grow lights (such as potting soil, containers, seeds, watering cans, etc.)*
- *Educational activities that support exploration of local food, agriculture, gardens, and nutrition*
- *Purchase/development of gardens*
- *Resources or education for families and the community (i.e. sending bags of local food home with families, related information, activities/workshops, seeds, materials, etc.)*
- *Purchasing of local foods for meals and/or snacks*
- *Developing capacity to serve as a Community Supported Agriculture (CSA) distribution site.*
- *Establishing a Farmer's Market at your program*
- *Establishing your program as a WIC check distribution site*
- *Increasing access to local foods for program, staff, and/or families*
- *Other locally designed activities to increase your programs Farm to ECE capacities*

Successful grants will be funded for a minimum of \$500 and a maximum of \$5000.
